PRIVACY POLICY

2_ Forms and Collection Methods Your personal information is collected by the following methods:

We will not use your data beyond what we disclose.

3_ Log Files and Cookies

We collect certain information through log files and cookies. These files allow us to process statistics and traffic information, facilitate navigation and improve the service for your convenience.

i) Description of the cookies used by the site This is mainly the following information:

- IP address
- Operating system and/or Device
- Pages visited and path
- Time and day of connection

The use of such files allows us to achieve the following purposes:
